### Accessibility Plan 2016 - 2017

St. Luke's is committed to providing a fully accessible environment which values and includes all pupils, staff, parents and visitors regardless of their age, education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to living by Christ's example by challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion.

The Accessibility Plan will contain relevant actions to:

- Improved awareness of **Equality and Inclusion**.
- Improve the access to **the physical environment** of the school, adding specialist facilities where as necessary. This covers the physical environment and physical aids across education.
- Increase access to **the curriculum** for pupils with a disability, expanding the curriculum so that all pupils with a disability are as equally prepared for life as are able-bodied pupils. This covers teaching and learning and the wider curriculum of the school such as participation in after school clubs, leisure and cultural activities and off site trips and visits. It also covers specialist aids and equipment which may assist these pupils in accessing the curriculum.
- Improve the delivery of **written information** to pupils, staff, parents and visitors with disabilities. For example, handouts, timetables, textbooks, and information about the school and events. The information should be made available in various preferred formats within a reasonable time frame.
